Following the entry of the court's Order dated December 13, 2012 (DN 61) dismissing the chapter 11 bankruptcy case of Ying Hua Tam for failure to pay the filing fee, *pro se* litigant Yaodi Hu filed, and the court has denied, five motions premised largely on the notion that the

court should not have dismissed Ms. Tam's case.

Yesterday, Mr. Hu filed his sixth motion -- jointly in Ms. Tam's case and his own -- in which he again seeks, among other relief, an order compelling Ms. Tam and her non-debtor

husband to pay various filing fees. See Motion for Both Cases for an Order to Tams to Pay \$516

and Quarterly Fee Under Rule 1006 and 28 U.S.C. § 1930 (DN 76, the "Sixth Motion"). For the

reasons the court has given in its several orders entered after its dismissal order (see DNs 64, 68

and 74), the court will deny the Sixth Motion as it pertains to Ms. Tam's case.

Finally, the court is hereby putting Mr. Hu on notice that it will regard additional motions challenging the dismissal (or other issues addressed in the post-dismissal orders) as an abuse of

process, which the court will not hesitate to address under 11 U.S.C. § 105(a). The court has

made its view of Mr. Hu's filings quite clear, so further review of the court's decisions will

require invocation of appellate jurisdiction. Nothing in this order, however, should be construed as indicating that an appeal would be either timely or meritorious.

NOW, THEREFORE, IT IS HEREBY ORDERED that the Sixth Motion (DN 76) is DENIED.

IT IS FURTHER ORDERED that the Clerk shall deliver a copy of this Order to the Honorable Jeffrey R. Hughes.

IT IS FURTHER ORDERED that the Clerk shall serve a copy of this Order pursuant to Fed. R. Bankr. P. 9022 and LBR 5005-4 upon Ying Hua Tam, Yaodi Hu, and all parties listed on the mailing matrix herein, and by first class mail upon Andrew R. Vara, Esq., Assistant U.S. Trustee, Office of the U.S. Trustee, 201 Superior Avenue E, Suite 441, Cleveland, OH 44114.
